# **Global Tuition Fee**

School fees for 2025 will be issued under a two tiered (Years 7–9 and Years 10–12) Global Tuition Fee structure. This fee will include all charges relating to the delivery of curriculum including VET, Vocational Pathways, materials fees, camps, retreats etc. The Global Tuition Fee does not include any supplementary activities such as specialized camps, private music lessons, Marist sporting carnivals, immersion programs and overseas trips.

## **Financial Assistance**

#### **Fee Remission**

Parents experiencing financial hardship are encouraged to apply for remission. Application forms are available from the

Accounts Receivable Officer at The Hermitage Administration Centre. Applications need to be made annually.

It should be noted that students of a family receiving remission will not be eligible for extra-cur- ricular activities. This is due to financial support already being provided to the students by the College. Extra-curricular activities are those activities that parents/carers need to contribute to- wards financially so their child can participate. This is in line with our Global Fees Policy.

All applications for remission are treated in confidence.

#### **Camps Sport and Excursion Fund (CSEF) Payment**

# **Global Tuition Fee Payment Options**
